## WHAT WILL I DO?

Once you are selected to evaluate projects, you will:

- **evaluate investment proposals** in the different sectors of the Innovation Fund:
  - in the first phase (expression of interest), evaluation based on greenhouse gas emission avoidance, innovation potential and project maturity
  - in the second phase (full application), also based on cost efficiency and scalability
  - carry out or review the economic and financial due diligence of projects
- provide further **assistance** to projects especially on **financial structuring**
- follow-up and support the **implementation of funded projects**
- provide **advice** e.g. on grant agreement negotiations (setting milestones, grant disbursement and results achieved)



## WHAT ARE THE CONDITIONS?

- **Individual and team work: remote phase** (individual evaluation of 2-3 weeks) and **meeting** in Brussels (about 1 week, travel, accommodation and daily allowances included), **flexible working arrangements**
- A **varied team of experts** per proposal
- **Access to information** subject to **confidentiality and conflict of interest provisions**
